GENERAL VENDOR INFORMATION

IMPORTANT CHANGES TO STREET FAIR FOR JUNE 2008: There are several changes that will bring more excitement, variety and opportunity to Street Fair, including: 1) A Beer Garden in front of the Bryan Center with the Music Festival relocated to that area. 2) No booths on Glen St. 3) Booths extending farther south on Xenia Ave. 4) Food booths relocated from Short St. to Walnut St. 5) Non-food booths on Short St. If your booth space from last year is not available, we will do our best to accommodate your request for a new location.

FEES: **Non-Local** \$165/booth; **Non-Local Non-Profit** \$125/booth (only 1 non-profit booth/vendor). If you do not have a local physical business or resident address, you are considered a non-local vendor; a post office box does not qualify. If you are a local resident representing a group with an out of town location, you will not qualify for local rates. The \$10 Chamber discount is for one booth for Yellow Springs Chamber Members only. Checks will be deposited upon acceptance of the application. For insufficient fund checks, payment including a \$25 fee must be made in cash within 3 days of notification to maintain vendor space.

Additional Food Vendor Fees: **General Fee** for clean-up & trash collection... \$25; **Water** ... \$25; **Electrical** ... \$25. *Limited quantity of water & electric available to food vendors only.*

BOOTH SPACE SIZE: 10' long x 10' deep. Booths are set up back-to-back down the middle of Xenia Avenue, and curbside on Corry Street, Short Street and Walnut St. Your booth will be assigned by the Chamber. Vendors must provide their own canopy, tables, chairs, etc. All canopies must be fire retardant and secured to withstand heavy winds.

SET-UP: 7 a.m. – 8:45 a.m. You **MUST** empty your car and park it before you begin to set-up. Cars must be off the street by 8:45 a.m. Spaces not occupied by 8:30 a.m. will be considered 'no-show' and reassigned.

TAKE-DOWN: 5 – 6:00 p.m. **Selling stops at 5 p.m. Streets must be cleared by 6:30 p.m. There are no exceptions to this rule.** Violators may be barred from participation in future fairs.

DEADLINE: Completed applications using only current application forms should be mailed with appropriate fee to the Yellow Springs Chamber of Commerce and must be received by **April 18, 2008**. Notice of acceptance will be mailed starting **April 25**. Applications will be accepted beyond that time. If you do NOT get a space, your check will be returned.

FOOD VENDORS: Food vendors must check with the Greene County Combined Health District, 360 Wilson Drive, Xenia, OH 45385 (937-374-5600) for food handling and license requirements. Health Department inspects day of event. Food vendors must provide a **Certificate of Liability Insurance** with their application. Food vendors using charcoal must have fire extinguishers. Generators with advance permission only! Electricity is limited; 120-volt hookups (20 amps maximum per hookup) only. You are required to provide your own #10 or #12 wire extension cords. We prohibit 220-volt hook-ups and **ALL** hook-ups must be able to plug-in; we will not allow anyone to "wire in". Electricity will cost \$25 per hook-up. Water hook ups are available on a limited basis; hook up fee is \$25.

COTTAGE FOOD PRODUCTION: Food items produced in a person's home must be labeled according to Greene County Health Department regulations. Regulations will be included with your acceptance if indicated on the application.

PROHIBITED: No sale of guns, knives, water pistols, snappers, caps, explosives, or weapons of any type is permitted at the Street Fair; violations of the rule may result in removal from the event. No tobacco products, drug-related items or Silly String may be sold. No selling from vans or trailers except for food vendors. Walking Vendors are permitted with a permit, issued by the Chamber of Commerce on the day of the event.

CANCELLATIONS: Booths cancelled by May 23 qualify for refund of booth fee, minus \$25 processing charge. Booths cancelled later than this date do NOT qualify for a refund, under any circumstances.

NO RAIN DATE: Street Fair will go on unless there is a public safety issue; participation is choice of vendor.
