Private Citizen - \$40

Volunteer Only Non-Profit Organization - \$45

Business or Non-Profit Organization with Paid Staff:

One to Two Employees - \$60

Three to Five Employees - \$90

Six to Fourteen Employees - \$125

Fifteen to Thirty Employees - \$175

Thirty-one to Forty-nine Employees - \$215

Fifty or more Employees - \$350

New Membership Structure Effective 4/1/2021

Private Citizen or Volunteer Only Nonprofit - \$50

Business or Non-Profit Organization with Paid Staff:

Up to Three Employees - \$75

Four to Fourteen Employees - \$125

Fifteen to Forty-nine Employees - \$200

Fifty to Ninety-nine Employees - \$450

One Hundred or more Employees - \$525

Please note that membership “categories” based on number of employees have changed. Your business may be part of a different membership level than before.

Renew early and save! Any renewals made after April 1, 2021, even if due before that date, will be subject to the new fee structure.
